The attention of the District Educational Officers in the State is invited to the reference 1* read above wherein instructions have been issued on completion of Recruitment process under TET cum TRT 2014 in which clear instructions have issued for utilisation of the services of surplus 966 teachers in 9 Districts under D.E.O's pool.

Similarly, in the reference 2^{ss} read above, instructions have been issued to the District Educational Officers in the State for drawl of salaries of the teachers who are under DEOs pool may be claimed from the surplus vacant posts at the School level relating to their respective categories.

Even after the issue of the clarifications, the Drawal of salaries of the teachers who are under DEOs' pool is not yet cleared especially in East Godovan district.

Keeping in view of the position above, all the District Educational Officers in the State are bereby instructed to issue posting orders to all the teachers who are under DEOs' pool indicating them against the surplus vacant posts. Then only it will facilitate the Treasury authorities to create employee 1b to all the teachers concerned exembough kept with the DEOs' pool. The drawal of the saluries of the teachers who are kept in DEOs' pool is the responsibility of the respective drawing officers of the mandals concerned.

The District Educational Officers are hereby instructed to take recessory action immediately in the matter.

The category wise breakup is as follows:

Secondary Grade Teachers: 6007 Language Pandits: 858 School Assistants: 1878 Physical Education Teachers: 183

The District Educational Officers are further informed that in a rare event, all the 8926 newly recruited teachers were invited to Vijayawada for a public program where the Hon'ble Chief Minister of Andhra Pradesh personally administered the Oath of Commitment to them at Vijayawada on 01.06.2016.

It was clearly informed to the selected candidates that their date of joining would be 01.06.2016 being the date they reported for the Hon'ble Chief Minister's Oath programme.

It is pertinent to note that the said newly recruited teachers have been allotted to specific school and specific post against a clear vacancy. Hence, it is to be deemed that they have joined in respective vacancy/school on 01.06.16.

In view of the above circumstances, all the District Educational Officers are requested to issue necessary instructions to the respective Drawing and Disbursing Officers (DDO's) to claim the salaries of the newly recruited teachers from the date of joining ic., 01.06.2016.
